
IMPROVEMENT DISTRICT NO. 16

Ministerial Order

WHEREAS, the Advisory Council for Improvement District No. 16 has recommended that the keeping by any person of wild or domestic animals or poultry be prohibited in those parts of the Improvement District specified to be the Hamlet of DeBolt located therein; and

WHEREAS, it would appear that the keeping of wild or domestic animals or poultry in the said Hamlet is likely to cause a nuisance therein.

NOW THEREFORE, I, MARVIN E. MOORE, MINISTER OF MUNICIPAL AFFAIRS, by virtue of the authority vested in me pursuant to the provisions of Section 18(1) of The Improvement Districts Act, and amendments thereto, and Section 161(e) of The Municipal Government Act, and amendments thereto, DO HEREBY ORDER that the keeping by any person of wild or domestic animals or poultry is prohibited in those parts of Improvement District No. 16, being specifically the area known as the Hamlet of DeBolt in accordance with the Schedule "A" attached hereto and forming part of this Order.




HAMLET OF DeBOLT
