Every year our club takes part in an Achievement Day Show and Sale, where our members get to share the projects they have been working on all year with family, friends, and community members. Most of our members will also auction one of their projects for sale. This year, our club is operating independently as the DCC Ridgevalley 4H Multi-Club and as such, we will be hosting our first-ever local show and sale at the Cranberry Lake Rodeo grounds on May 24th and 25th. We have expanded our club and added new categories to our show and sale. This year, our members will present 21 steers, 12 heifers, 5 cow/calf pairs, 4 market hogs, 4 market lambs, 5 chicken pen projects, 2 baby beef projects and 2 baby swine projects.

While the rodeo grounds do provide our event with shelter for viewing participants, washrooms and a facility to serve meals and house our art exhibits, it does not provide shelter for our members or their project animals. To protect our members and their animals from the elements we have rented 2 - 40' X 60' tents to house the animals and cover the show ring during the event. We did look for a covered location within our local MD area but were unable to find one. We have fundraised and will continue to fundraise to cover the costs of our Achievement Day, but the costs associated with renting the tents were higher than we had budgeted for. We are asking the MD to help us cover the cost of the tents and to help make our first-ever DCC Ridgevalley 4H Achievement Day a success.
