## BACKGROUND/PROPOSAL:

Grande Cache currently does not allow detached trailers to be parked on streets. If the trailer is hooked up to a vehicle, they are allowed to be parked for an indefinite period. Community Peace Officers in the area have been receiving ongoing complaints regarding recreational vehicles (holiday trailers, rvs, etc.) continuously parked on residential streets. Administration is recommending an amendment to the existing bylaw, to alleviate long term parking of large recreational vehicles on residential streets and public highways to increase driver visibility and ease of movement. A person will be able to park for a short period of time, 72 hours, before the recreational vehicle needs to be moved off the street for at least 48 consecutive hours before it can be parked for another 72. This is to allow for loading and unloading. This amendment also contains a provision to change the name of the bylaw to Grande Cache Traffic Bylaw to clearly indicate the region of Greenview that the bylaw applies.

Administration is currently working on an overarching update and consolidation of the two current traffic bylaws. As this matter is currently ongoing, Administration is seeking an amendment only, at this time.
